

6 Guj students suspended, removed from hostel

BHAVNAGAR MEDICAL COLLEGE RAGGING CASE

Gujarat's Health Department has ordered strict disciplinary action against six students of the Government Medical College in Bhavnagar after an investigation into a ragging complaint found them guilty, with one student suspended for two years and all six ordered to vacate their hostel rooms immediately.

The action followed a marathon meeting of the college's Anti-Ragging Committee,

which began at 5 p.m. on June 18 and continued until 2 a.m. on Friday. The meeting was convened on the instructions of State Health Minister Praful Pansheriya after the alleged ragging incident was reported.

According to the Health Department, the case was treated with urgency by officials in Gandhinagar, the Additional Director and the Anti-Ragging Committee.

During the nine-hour meeting, written statements were obtained from first-year, second-year and third-year students of the Orthopaedics Department, as well as from concerned faculty members and support staff.
