# In Manipur, six bodies suspected to be of missing Naga men found

Guwahati, June 11

TWENTY-EIGHT days after six Naga men in Manipur went missing and were suspected to be abducted, six bodies were recovered by security forces on Wednesday afternoon, with police saying they are "believed to be among those" kidnapped on May 13.

Search operations for the six missing men from Konsakhul, a Naga village in Manipur's Kangpokpi district, have been underway for the past four weeks. The development comes a day after Naga groups released 14 Kuki men they had been holding hostage in Senapati district, demand-

ing that the six men from their community be located and handed over. "After nearly 24 hours of sustained search operations involving around 450 personnel of the Manipur Police, CRPF, and Assam Rifles, assisted by sniffer dogs and forensic expert teams, the mortal remains of six persons were recovered this afternoon.

The deceased are believed to be among those taken hostage from Leilon Vaiphei on May 13. Necessary legal formalities are being carried out by the police, and the investigation is underway," said a statement issued by the Manipur police on Wednesday evening.

A senior security official said that the bodies were lo-

cated in an area between Leilon Vaiphei and Kharam Vaiphei, close to where a large number

communities have spiked after three church leaders from the Thadou Baptist Association were killed in an attack, which Kuki groups alleged Naga armed groups were responsible for.

In response, a number of Naga villagers were abducted, including several people who were returning from a wedding party on May 13.

The six missing Naga men had been identified by locals of Konsakhul as Manu Thiunmai, Kenpibou, Dilip Thiunmai, Phenrilungbou, Kaliwangbou, and Phenrongwibou. Manu Thiunmai and Kenpibou were pastors.

Subsequently, Naga groups had also abducted more than two dozen Kuki villagers in Senapati district.

## Four senior citizens among 8 injured in fire at Mumbai building

**Mumbai:** Eight people, including four senior citizens, were injured after a fire broke out in an air-conditioning unit at an 11-storey residential building in the upscale Juhu area of Mumbai on Thursday morning, civic officials said.

Six of the injured were admitted to a hospital and stated to be in stable condition, they said. The fire was confined to an AC unit on the sixth floor of the 11-storey building, an official said, adding the cause was not yet known. PTI

# Centre approves price hike for four medicines, including two cancer drugs

THE CENTRE on Wednesday approved the increase in prices of at least four medicines, including two commonly used chemotherapy drugs, whose shortage across the country was affecting treatment of cancer patients.

"NPPA has sought the approval of the DoP [Department of Pharmaceuticals] ... to increase price in respect to four formulations.... In this regard, it is conveyed that the in-principle approval of the Hon'ble Minister ... is granted," said a letter dated June 7 from the DoP to the National Pharmaceutical Pricing Authority (NPPA).

The four formulations include the platinum-based chemotherapy drugs Cisplatin and Carboplatin, along with two anti-tetanus injections.

These are essential medicines whose prices are controlled by the NPPA under its Drug Prices Control Order 2013. This order essentially allows companies manufacturing these important drugs to raise its price only once a year as per the increases in wholesale prices.

The NPPA has been asked by the DoP to examine the increase in the cost of raw materials for these drugs and allow the price increase accordingly. "The increase in raw material data given by the company and assessed by NPPA should form the basis for giving the price increase," the letter stated, adding that the increase should be guided by previous formula given by a standing committee that the increase should be between 10% and 50% from the last fixation.
