In terms of Regulation 51 of the SEBI Listing Regulations, we wish to inform that the Nomination and Remuneration Committee of the Board of Directors vide its resolution dated 17 September, 2025 has approved the allotment of:

- (a) 1,25,000 Equity Shares of face value of Rs. 10/- each upon exercise of options granted under the Grihum Housing Employee Stock Option Plan 2018 ('ESOP Plan 2018') and Grihum Housing Employee Stock Option Plan 2021 ('ESOP Plan 2021') of the Company; and
- (b) 62,500 0.001% Compulsory Convertible Preference (CCPS) Shares of face value of Rs.10/- each in the ratio 1:2 upon the exercise of options granted under the ESOP Plan 2018 and ESOP Plan 2021 respectively of the Company.
