

Scramble for legislative council seats in Bihar begins

Amid full-throttle guesswork over the name of Bihar's next chief minister, various political parties have started bracing up for the elections to Bihar legislative council.

A total of nine MLC seats are set to become vacant in June 2026. By-polls will also be held to two seats - vacated by Bihar chief minister Nitish Kumar following his election to Rajya Sabha, and also by Bihar health minister and senior BJP leader Mangal Pandey after he was elected to the assembly in the last state polls.

AIMIM is likely to field a candidate in the polls and gets support of RJD and other allies of the Mahagathbandhan as the former had extended support to the RJD candidate in the last Rajya Sabha polls.

A total of nine MLC seats are set to become vacant in June 2026

win 10 of these seats, while one seat will go to the Mahagathbandhan. Of the 10 seats allocated to the NDA, one is considered virtually reserved for state panchayati raj minister Deepak Prakash, son of RLM chief and Rajya Sabha member Upendra Kushwaha.
