

19 convicted over Moscow concert attack

Moscow: A court in Moscow on Thursday convicted 19 people over their involvement in the 2024 shooting attack at a concert hall that killed 149 people and wounded more than 600 in one of the deadliest assaults in the Russian capital in years.

A faction of the Islamic State group claimed responsibility for the March 22, 2024, attack at the Crocus City Hall concert venue. Four gunmen opened fire on people waiting for a performance by a popular rock band and later set the building on fire.
