

UGC, AICTE to join hands for similar functions

New Delhi: Coming together for the first time, two higher education regulators — University Grants Commission (UGC) and All India Council for Technical Education (AICTE) — have decided that a “cluster approach” may be adopted by chubbing officers of both to carry out similar functions.

At a meeting on Wednesday of the bureau heads of AICTE and UGC, both regula-

tors agreed to work mutually in the areas of research and innovation, e-governance, translation of books in regional languages and examination reforms, among others. The meeting was chaired by UGC chairperson, M Jagadeesh Kumar, who is also the interim chairperson of AICTE. Kumar at the meeting noted the need for unified functioning, standardising regulatory framework, and standardised processes.

Kumar emphasised that both the regulators “must work in a synchronised manner, learn from each other, share and adopt each other’s best practices”.
