

Authorities on high alert after Pantnagar airport receives bomb threat

 $T_{\rm placed\ Pantnagar\ airport}^{\rm he\ authorities\ on\ Tuesday}$ in Udham Singh Nagar district on high alert following a bomb threat received by email. The airport security as well as the police stepped up security measures soon after receiving the threat, the superintendent of police of Rudrapur Manoj Katyal told The Pioneer. Since similar threats were recently made against schools in Delhi and Uttar Pradesh, this threat also escalated concerns among airport authorities and the police. The SP said that the authorities have been conducting rigor-

ous checks at the airport and the nearby areas since they received the information about the bomb threat. The vehicles were also being parked outside the premises for safety reasons. The police along with the departments concerned conducted all checks to detect any possible bomb. The senior superintendent of police of Udham Singh Nagar Manjunath TC also visited the airport after getting information about the bomb threat. He said that the airport administration has also taken comprehensive measures to ensure the safety of passengers and

staff. The airport administration also mobilised security personnel to conduct thorough checks on all individuals entering the airport. They also requested additional forces from the district administration to strengthen security. The police also deployed additional personnel at the airport for security purposes. The SP said that all necessary precautions were taken to manage the threat and maintain the airport's operations without compromising on safety. Police are vigilant and investigating the threat, he added.

STF busts fake call centre in Haridwar

The Uttarakhand Special Task Force (STF) busted a fake call centre in Haridwar from where people across the country were duped under the pretext of selling credit cards. The accused was arrested under the STF's new campaign "Will not let Uttarakhand become Jamtara" as Jamtara in Jharkhand is considered to be the country's cyber crime hotspot. Since STF has recently arrested several such groups across the State that were duping people across the country, it started a campaign to nab all such groups that can potentially turn cities here into a cyber crime hotspot. The senior superintendent of police of STF Ayush Agrawal said that the STF received a tip-off that a gang is active in the SIIDCUL area of Haridwar that has been

duping people across the country under the pretext of selling credit cards. The gang is reportedly involved in at least 22 cyber fraud cases all across the country. The SSP said that the STF team raided a house in Ramnagar colony under the SIIDCUL police station area late on Monday and found only one person named Vipin Pal (26) on the spot. The team also recovered six mobile phones, four empty mobile phone boxes, one computer, 14 debit cards, three registers and one cheque book of ICICI bank, among other items. The STF registered a case against the accused and his gang under section 419, 420, 120 (B) of the Indian Penal Code and section 66C, 66D of the Information Technology Act at the SIIDCUL police station. added

Agrawal said that Pal told during interrogation that he is 10th pass and has been duping people for the past several years by making calls through mobile in the name of providing credit cards, insurance and various loans. Several other people are involved with him in the crime who also sold him the contact details of the victims. He had also hired some women to make calls to potential victims across the country. The police have found a transaction of over Rs 70 lakh in his account. The SSP said that the gang members used to send a link to the victims in the name of helping them get credit cards and once they clicked on it, they got access to their whole data. The STF is working on arresting other gang members, he

Speeding & mobile phone use fuelling road accidents: Sanjay

The increased number of I road accidents can be attributed to overspeeding and using mobile phones while driving, orthopaedic surgeon and Padma Shri recipient Dr BKS Sanjay said. Addressing the media at the Press Club on Tuesday, he said that to raise public awareness on the rising number of road accidents, he and the SHEWA have organised a week-long series of public awareness lectures to mark the eighth UN Global Road Safety Week from May 10 to 14 in Dehradun. He emphasised that WHO reports revealed that nearly five lakh

ities. The frequency of accidents grows along with the nation's population and the number of vehicles. According to data from the Transport department, India has only one per cent of the world's vehicles but accounts for 11 per cent of the world's accidents. Road traffic accidents have become an epidemic in our country, he added. Dr Sanjay emphasised that 90 per cent of these accidents are caused by drivers' negligence and that mets they can and should be prevented. Additionally, he stressed on the importance of wearing helmets to mitigate the impact of road accidents. enforce these rules Orthopaedic surgeon Dr Gau-

rav Sanjay stated that the major causes of road traffic accidents are overspeeding, drinking and driving, using mobile phones, sleep depriva tion and driver fatigue. He said that human resources are the greatest resource on Earth and suggested that 20 per cent of fatalities in accidents involving two-wheelers and 20 per cent in accidents involving four-wheelers can be pre vented simply by wearing heland seat belts respectively. He appealed to the public to learn and follow traffic rules and also urged the government to educate and

MCD to form committee to analyse objections raised by slum dwellers

The Municipal Corporation of Dehradun (MCD) will form a committee on May 16 to analyse the objections received from slum dwellers residing on the riverbed of the Rispana river. The corporation has received only about 20 to 30 objections from slum dwellers out of 89 notices issued so far in the first phase. The recipients of these notices can submit objections till Wednesday evening, the Dehradun municipal commissioner Gaurav Kumar said. The corporation formed a task force to conduct a survey to remove encroachments on the riverbed of the Rispana and Bindal rivers as per the orders of the National Green Tribunal (NGT). In the first phase, the teams identified 525 encroachments in 129 slums alongside the Rispana river that were set up after 2016. The MCD team found after the analysis of the collected data that out of 525 identified encroachments, over 400 structures were formed on MDDA's land, 12

The commissioner said that the committee will be formed to analyse all the objections raised by slum dwellers. Tn an important step the Reserve Bank of India (RBI) has Lallotted Real Time Gross Settlement (RTGS) to 15 branches of Uttarakhand State Cooperative Bank. These banks have started operating with the facility which is provided after strict scrutiny by the RBI. Maintaining less than five per cent Non Performing Assets (NPA) is also an important eligibility criterion for the RTGS facility. Expressing happiness, the Cooperation minister Dhan Singh Rawat said that the online banking service being strengthened is a positive development which will benefit both the banks and customers. He said that in absence of RTGS, the cooperative banks of the State used to work under RTGS of some private banks and for it they had to keep Rs 100 crore in the current account of the private bank. The cooperative banks will now keep this money with them and will earn interest by investing it. The minister said that soon RTGS for the district cooperative banks will also be sought and till then these banks will be sub members of the RTGS of the State cooperative banks. He said that with regular monitoring the State Cooperative Bank has been successful in bringing down the NPA to less than five percent which played a key role in awarding RTGS. The cooperative banks also started a campaign for NPA collection which was successful. The gross NPA of State Cooperative Bank and 10 district cooperative banks was Rs 603 crore on March 31, 2023 which on March 31, 2024 was reduced to Rs 538 crore. The net NPA of the banks on March 31 last year was Rs 221 crore which was Rs 156 crore on March 31 this year. The minister said that the State government has taken many initiatives to strengthen the cooperative banks which has made them more competitive and equivalent to the nationalised banks.

NMC approves three seats for DM in cardiology & critical care medicine at SRHU

The National Medical Commission (NMC) has approved three seats each for DM in Cardiology and DM in Critical Care Medicine at the Himalayan Institute of Medical Sciences (HIMS) at Swami Rama Himalayan University (SRHU). The principal of SRHU Ashok Deorari stated that the NMC team sought a report on the available facilities at the college and hospital. Based on the report, the NMC has approved three seats each for DM in Cardiology and DM

in Critical Care Medicine in the PG (MD) course. Additionally, permission has been granted to increase four seats in MD in Anesthesiology. Deorari emphasised the importance of critical service in any hospital and highlighted the shortage of specialists in critical and super specialty healthcare across the country. He said that with the NMC's approval, the total PG seats at HIMS have now increased from 123 to 127, and the super specialty course selling, Deorari added. seats have increased from 12

to 18. The Medical Assessment and Rating Board had set stringent standards, including department-specific clinical materials, compli-ance reports, availability of blood components, functional essential equipment, number of units, number of beds in the department and faculty numbers, he said.
