

BRITISH TEEN RAPISTS ESCAPE JAIL, PAY ₹26

London: Three teenage boys convicted of rape and serious sexual assault in north-east England were given youth rehabilitation orders and required to pay just £26 in court fees, sparking outrage, The Guardian reported.

The offenders, aged 14 to 17 at the time of their crimes, avoided custody despite attacks on girls as young as 14. Victims and campaigners criticised the sentences as lenient, while the UK government said serious offences should always warrant consideration of imprisonment.
